Captivating Dance by Nona's provide students the opportunity to explore and progress in many styles of dance. There are four levels of competition teams. Please read them carefully.

The CDBN "COMPANY" Competition Team

This is an elite dance competition team that focuses on bringing each dancer to their fullest potential. This team is designed for dancers who are serious about dance and their technique. Discipline, commitment and dedication from student, parent and teacher are shared through the passion of dance and strive for excellence. This team competes year round at several competitions (~4). The schedule is rigorous and focuses on making each dancer technically sound in all styles of dance. Many company dancers have received full ride scholarships to four year universities and have gone on to become professional dancers, teachers and choreographers. This elite team provides dancers the tools to bring their technique and performance to the next level.

"Hip Hop/Tap ONLY" Competition Team

This is an elite dance competition team that focuses on a specific style of dance and only competes in one style. This team is designed for dancers who are serious about dance and their technique. Discipline, commitment and dedication from student, parent and teacher are shared through the passion of dance and strive for excellence. This team competes year round at several competitions (~4). The schedule is rigorous and focuses on making each dancer technically sound in one style of dance.

"Demi" Competition Team

This is a great way to be part of an elite dance competition team in a smaller setting. The Demi Competition Team is created for those dancers who need more flexibility in their schedule and wish to take a milder approach to strengthening their technique. It opens the doors for dancers to take open classes and learn fun combinations without the stress of memorizing it week to week. This is a great way to start the team and provide an opportunity to dancers experience what it is like to be on a dance competition team.

"Next Stars" Competition Team

This is a fun way introduction to a dance competition team. This team has been created to give younger students the ability to learn teamwork, discipline and commitment. This team will learn 2 dances and only attend two competitions for the year.

Only returning CDBN dancers will be considered for solos, duets or trios.

I, _____ (Name of Parent or Legal Representative), acknowledge that my daughter, son, and/or child for whom I have legal custody has voluntarily applied to engage in dance and dance-related programs and activities with Captivating Dance by Nona. I understand I should be aware of my child's physical limitations and agree to inform the studio of such limitations.

I understand that participation in dance class, practice, workshop, camp, intensive, rehearsal, performance, competition or other dance activity is potentially risky. I knowingly and voluntarily agree to assume all reasonable risks and responsibilities for any such injury or accident, which might occur to my child or me before, during, or after any Captivating Dance by Nona dance or dance-related activity that my child or myself has chosen to participate in except for those resulting from negligence or willful misconduct on the part of Captivating Dance by Nona or any of its agents. I am aware that Captivating Dance by Nona classes may be given both on the campus of Menlo-Atherton High School and at the Captivating Dance by Nona studios on Menalto Avenue, Menlo Park CA, and that my child may on occasion chose to use facilities or patronize businesses outside of the dance studio and I understand that Captivating Dance by Nona is not responsible for any injury or accident that occurs under such circumstances unless it arises due to negligence or willful misconduct on the part of Captivating Dance by Nona or any of its agents.

I am aware that my child may on occasion be driven by an agent of Captivating Dance by Nona either between studios (classes are given on the campus of Menlo-Atherton High School and/or the "Menalto Studios" located at 1919 & 1923 Menalto Ave, Menlo Park) or to or from a competition, convention or other dance-related activity as a convenience to parents and I understand that Captivating Dance by Nona is not responsible for any injury or accident that occurs under such circumstances unless it arises due to negligence or willful misconduct on the part of Captivating Dance by Nona or any of its agents.

I knowingly and voluntarily exempt, release, indemnify, and hold harmless Captivating Dance by Nona, its owners, agents, volunteers, assistants, employees, guest artists, faculty members, independent contractors, and/or students from any and all liability claims, demands, or causes of action whatsoever from any damage, loss, injury, or death to me, my children, or property which may arise out of or in connection with participation in any classes, activities or events conducted by Captivating Dance by Nona, except for those resulting from negligence or willful misconduct on the part of Captivating Dance by Nona. I further hereby knowingly and voluntarily agree to waive my rights and that of my heirs and personal representative(s) to hold Captivating Dance by Nona, its owners, agents, volunteers, assistants, employees, guest artists, faculty members, independent contractors, and/or students liable for such damage, loss, injury, or death.

Media Release & Authorization

I hereby give Captivating Dance by Nona permission to use still or video images of my child dancing with Captivating Dance by Nona in any reasonable form of advertisement for the studio.

Medical Authorization

I hereby give Captivating Dance by Nona permission to seek emergency treatment for my child and I authorize Captivating Dance by Nona representatives to give permission for the performance of emergency medical and dental examination(s) and necessary treatments (including tests, x-rays, medication or emergency procedures) as deemed necessary by the physician/dentist in attendance. If any emergency arises, Captivating Dance by Nona representative will attempt to reach me and/or my child's emergency contacts and be guided by given instructions. If I cannot be reached, I authorize the attending physician/dentist to act as reasonable medical judgment dictates. I agree to accept financial responsibility for the costs/debts related to any and all emergency treatment deemed necessary by the physician/dentist in attendance. General Competition Team Guidelines

Placement of dancers is FINAL. Dancers have been placed in specific groups based on the following: their ability to focus, attitude, overall impression, projection, execution of style(s), technical skills, synchronization, and control. Students do not have to accept this offer. It will involve more time and financial commitment if invitation is accepted.

General Student Responsibilities:

ALL competition team members are expected to commit to do the following:

1. To compete for Captivating Dance by Nona ONLY and not for any other dance studio.
2. To be dedicated to their team and team members.
3. To be responsible for their schedules, costumes, and behavior.
4. To show respect and a positive attitude at all times.
5. To attend all required classes, competitions, conventions, and performances per the team requirements.
6. To make dance their #1 priority for their extra-curricular activities.
7. To attend mandatory rehearsals prior to each performance event.
8. To wear team warm-ups to all competitions and performances.
9. Follow all studio rules, regulations, and policies.
10. Sportsmanship is a primary responsibility of performance team members.

General Parent Responsibilities:

ALL competition team parents are expected to commit to the following:

1. Pay all team fees and tuition by deadlines due.
2. Ensure that team members are registered for and attend all classes per the requirements listed on the minimum class requirements list.
3. Ensure that team member arrives to all practices/performances prepared and on time.
4. Informs Captivating Dance by Nona well in advance through absent request forms at least 2 weeks in advance if team member is unable to attend a required practice or competition other than for illness.
5. Review "Examples of Competition Team Expenses" and understand the financial commitment.
6. To review "General Performance Team Guidelines" and agree to those guidelines.

Additional Policies and Requirements:

It is mandatory for all team members to perform at all competitions. Team members 12 years and older will attend conventions. Convention is mandatory in the 2019-2020 dance season.

Individualized competition, convention, choreography, and costume fees will be charged to the card on file. Please understand that some expenses are unforeseen and may arise during the dance year. Competition fees will be due in 4 installments. 1st installment due August 1st (\$700). 2nd installment September 1st (costume fees and any balance on 1st installment). October 1st (\$700 and any balance of costume fees) November 1st (remaining balance of competition fees). All estimated costume fees are due September 1st. Choreography fees for solos, duets and trios are due at the first session. You will be able to Venmo or Paypay your choreographers. All team fees paid to CDBN are non-refundable and will not be reimbursed after due date has passed for these fees. All choreography provided to the CDBN team and its members are owned by CDBN and they cannot be taught or used without permission.

I understand that I must give 30-day notice to drop from a team and/or any classes at CDBN. I acknowledge that I will not receive any refunds for payments rendered.

If a team member misses a mandatory team practice prior to a performance, they may not perform at that particular performance (competition) – the decision is at the coach(s)' discretion. Any practices 2 weeks prior to a performances are mandatory and students that miss those rehearsals can or will be removed from that specific performance.

All CDBN team members pay monthly tuition through the card on file at our MINDBODY website. No checks for tuition or installments will be accepted. Choreography fees must be paid by Venmo or Paypal to individual choreographer on the first practice.

Monthly tuition covers all weekly team practices, regular classes, mandatory regular classes, extra team practices deemed necessary by teacher, mandatory rehearsals before events, choreography of regular dance team routines, and staff for competitions, conventions, and recital. I understand that my monthly tuition DOES NOT cover all other performance team expenses.

Choreography fees cover ten 30min privates as well as staff at competitions. Privates not used will not carry over to the following year.

I have read "Examples of Competition Team Expenses" and understand the financial commitment involved for my child to be part of the performance team.

Competition team parents are encouraged to attend a parent informational meeting that will take place on Sunday, **August 25, 2019** at the 1919 Menalto Studio at 2:00pm.

I have read and understand all of the above information. I have reviewed the "Examples of Competition Team Expenses" in which my child and I have no conflicts with and will comply. I confirm my commitment to the CDBN dance team. I have informed my child of all expectations and responsibilities they will need to comply with as a CDBN team member.

Audition Results and Team Invitations

Results of competition team auditions will be emailed on or before May 21, 2019. If you receive an invitation to be part of a dance/team, you will be receiving a team agreement with more specific requirements for the specific team. Most likely, you will NOT make all of the dances you audition for. We have limited spots per dance. If you did not make a particular dance for which you auditioned, you will be put on a waitlist in order of best to lowest tryout score for that particular dance. If someone that received an invitation for that dance does not commit to that dance by **May 27, 2019** we will be sending out invitations to those on the waitlist in order of highest score to lowest score.

I understand that there is a **\$500 charged for all dancers per child ALL** due on **May 27, 2019** to hold my child's spot for performance team dances he/she has been offered to perform in. **This will be charged on to my card on file at our MINDBODY website.** The deposit confirms mine and my child's commitment to the team. I also understand that all payments are **non-refundable** and will be applied towards my child's team fees in the fall. You can email CDBNstudio@gmail.com to accept, decline or request to be added to more dances no later than May 25, 2019. You may also request to break the deposit and tuition into smaller installment plan. I understand that if my child accepts placement on company or demi teams that my card on file at MINDBODY website will be charged **first and last months tuition (\$1000) on June 1st and \$500 at the beginning of every month until April 2020.** Hip Hop/Tap Only tuition is \$360 due at the beginning of the starting August through May.

I understand that if my child accepts placement on next stars/hip hop only that my card on file at our MINDBODY website will be charged tuition starting in September-May. In addition to monthly tuition, I understand that all of my installments will be charged on the card on file on our MINDBODY website on the dates stated above. Any declined chargers are subject to an additional \$25 processing fee.

Please understand that we will charge the deposit on May 27, 2019. If you want to be removed from the team roster and not be charged the \$500 deposit you will need to notify us by May 28, 2019 at CDBNstudio@gmail.com and your spot will be given to another dancer.

Students are accepted to become a Captivating Dance Competition Team member based on audition by Kate Lynn Roberts and Nona Ybarra - at their sole discretion.

Teachers reserve the right to move a team member from one team to another based on technical ability and/or dedication.

Teachers reserve the right to determine if a team member will be allowed to participate in a team event and/or remain on their team(s) based on commitment to teachers, and/or fellow dancers, and/or themselves, and/or parent(s) commitment to their child's team.

*Any student may apply for a scholarship or partial scholarship. These applications need to be COMPLETED and turned in with student's competition team audition form on **May 3, 2019**. Not all students who apply will be given a scholarship or partial scholarship. Scholarships are given to low income and at-risk students. Funds are limited. A scholarship awarded in prior years does not guarantee a scholarship for every year. An application must be submitted yearly for consideration.*
