Captivating Dance by Nona's REGULAR (OPEN) dance classes provide students the opportunity to explore and progress in many styles of dance. The regular classes also provide students the opportunity to perform without the pressure of competing (will participate in a year end recital).

The CDBN "COMPANY" Competition Team

This is an elite dance competition team that focuses on bringing each dancer to their fullest potential. This team is designed for dancers who are serious about dance and their technique. Discipline, commitment and dedication from student, parent and teacher are shared through the passion of dance and strive for excellence. This team competes year round at several competitions (~4). The schedule is rigorous and focuses on making each dancer technically sound in all styles of dance.

"Demi" Competition Team

This is a fun way to be part of an elite dance competition team in a smaller setting. The Demi Competition Team is created for those dancers who need more flexibility in their schedule and wish to take a milder approach to strengthening their technique. It opens the doors for dancers to take open classes and learn fun combinations without the stress of memorizing it week to week. Stress level will be low because there are fewer dances to learn and only one to two competitions for the year. This is a great way to start the team and build your strength or it is an opportunity to take a step back from the rigorous competition team.

Only returning CDBN demi or company dancers will be considered for solos, duets or trios.
